Membership

Membership of the Victorian Recorder Guild offers the chance to connect with other recorder players and to participate in Guild events such as occasional workshops, blow-ins, soirees, concerts, and a residential weekend of music -making. Members in Victoria may borrow music (including sets of multiple copies) from the extensive library free of charge. Members will receive a newsletter and notices of events by email. Printed newsletters forwarded by post are available for an additional cost.

Types of Membership

Full: For individuals

Concession: For individuals receiving a government pension and for full-time students

Family: For members of a family living at the same address. Please provide names of people to be included.

Group/School/Institution: Only the nominated representative of the group has the same rights as an individual member. Members of the group are not Guild members but they may enjoy the use of music borrowed from the library by their group representative and keep in touch with information through their representative. They may also participate in some Guild events – such as blow-ins. However, in most instances if non members participate in Guild events they will be charged at a non member rate.
